The Company will cancel the repurchased shares. Following the purchase and cancellation of these shares, the remaining number of ordinary shares in issue will be 2,819,274. The Company holds 62,500 ordinary shares in treasury therefore, the total voting rights in Camellia will be 2,756,774. This figure for the total number of voting rights may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
